Bryan Foley motioned to recommend the award be 10% of lost revenue May through August 2023 vs the same months in 2022. Valory Brown supported the motion. Motion passed. Yes - 3, Abstained - 1 (Lambert)

Valory Brown motioned to recommend that any money leftover in the fund be considered for technical and educational support for downtown businesses. Bryan Foley supported the motion. Motion passed. Yes - 3, Abstained - 1 (Lambert)
